Instructions for Parents Regarding Non-Consent to Human Sexuality Instruction

Dear Parents and Guardians:

Thank you for your interest in protecting your children from explicit human sexuality materials and instruction in public schools, as well as more subtle attempts by school districts under guises such as “anti-bullying,” “support,” “diversity,” and “inclusion.” Attached to this Memo is a Parental Non-Consent Form that you can fill out for each of your children and present to the principal or other administrator at your school. You should fill out two copies for each child, one for the school to keep in your child’s file, and one for you to keep for your records. There is a place at the bottom for the signature of the person who receives the form, and the date it was received. If the recipient questions signing the form, thinking that they are somehow approving it or agreeing with it, indicate that it is only stating that it was received on a certain date. As an alternative, they can use a “received” stamp with the date to record that it was provided to the school.

The purpose of this form is to put the school on notice regarding what is/is not acceptable for your child with regard to the issues described in the form. Regardless of whether the school has another form for consent or no form at all, the Parental Non-Consent Form places the school on notice of precisely what you are/are not consenting to. If there is a “school approved” form, you can attach this form to it, and write on the school form that there is an attached form that specifies your instructions regarding your child.

You might get some pushback about whether this is legally binding on the school. You do not need to engage in a discussion with the administrator on that, but simply state that regardless of what the school believes is its legal effect, you are requesting that the Parental Non-Consent Form be placed in your child’s file along with the other forms, *e.g.* medical releases, student handbook receipts, permission slips, that are kept there.

The question of what legal effect the form will have if the school ignores what you have requested depends upon the laws of each state. Therefore, we cannot say that we can file a lawsuit against the school or take similar legal action in general, but Liberty Counsel will examine each case in light of the state laws. However, it does put the school on notice, and eliminates the excuse that they did not know that certain material was objectionable. Also, if the school ignores your requests and shows objectionable material you can certainly make that public at a school board meeting and/or in local media.

Continuing Written Notice under Mich. Comp. Laws § 380.1507a
Human Sexuality Instruction Parental Non-Consent Form
For the _____ School Year

I, _____, as parent and/or legal guardian of my minor child,

_____, hereby exercise my right as a parent under the U.S. Constitution, and the Constitution and laws of the State of Michigan, to direct the upbringing and education of my minor child.

This document constitutes my Continuing Written Notice pursuant to M.C. L § 380.1507a, by which “a pupil shall not be enrolled in a class described in” M.C.L § 380.1507, which defines “class” to encompass “an instructional period of limited duration within a course of instruction and **includes an assembly or small group presentation.**”

1. MY CHILD SHALL NOT be enrolled in any instruction or discussion on human sexuality which is derived in whole or in part from; contains information from; or references to the following sources:

2. MY CHILD SHALL NOT be given instruction or information on, or be subjected to discussion of any aspect of human sexuality, including the following:

- A. Abortion;
- B. Birth Control/Contraceptives;
- C. Sexual activity of any kind whatsoever, including, but not limited to, vaginal, oral or anal sex;
- D. Sexual orientation, including, but not limited to any variant of homosexuality, including but not limited to, lesbian, gay, bisexual, queer, or questioning identities;
- E. Transgenderism or gender identity, including, but not limited to, gender as social construct; gender binary; gender spectrum; gender reassignment surgery, gender dysphoria, false gender pronouns, gender expression, or cross-sex hormones;

- F. Any referral of my child to a counselor, medical professional, social worker, within or outside the school for purposes of discussing sexuality, or any of the topics listed herein;
- G. Any written material of; reference to; or referral to an outside agency, group, individual or organization relating to sexuality or gender identity (including, but not limited to those listed in Section 1).
- H. Any reference to or participation in a personal analysis, evaluation or survey that reveals or attempts to affect my child’s attitudes, habits, traits, opinions, beliefs or feelings concerning: political affiliations; religious beliefs or practices; mental or psychological conditions; sexual behavior or attitudes; sexual activity; sexual orientation; gender identity; or illegal, antisocial, self-incriminating or demeaning behavior;
- I. Any advertisement of or participation in any assembly, meeting, group, organization, club, entity or activity that discusses or addresses sexual activity, sexual orientation or gender identity, under the guise of “bullying,” “support,” “diversity,” “inclusion,” or other rationale;
- J. Any additional instruction and discussion, including but not limited to: classroom teachers, school staff, third-party providers, YouTube or other videos, films, livestreaming, other audio-visual methods, textbooks, workbooks, or handout material, including any entity listed under Section 1 or any topic listed under Section 2. I am requesting alternative academic instruction for my child during the same period that any instruction on any aspect of human sexuality is provided.

I request that my child be given alternative instruction during the time that these materials and subjects are being presented.

I hereby request that this notification be placed in my child’s permanent file and be provided to all people offering instruction to my child during the school year. Any instruction or actions by the school contrary to this notice will be the subject of further action to protect my child.
